


CONTRIBUTION OF THE EQUINE INDUSTRY TO THE ECONOMY OF SOUTHEASTERN PENNSYLVANIA

STUDY OBJECTIVE

- Estimate the size, composition and contribution of the equine industry to the economy of the 10 county region.
- Last study was conducted by PSU in 2003 and covered the entire state.



INITIAL AREA OF ANALYSIS

- Region of analysis covers 10 counties in SEPA.
- Accounted for 32% of Pennsylvania equine farms and 36% of equine population in 2012.

- Individual horse and other equine owners
- Boarding and training facilities
- Equine instruction
- Breeders
- Fairs and shows and other equine events
- Academic institutions and government
- Suppliers of professional equine services
- Equine-related organizations

WHERE DOES THE ECONOMIC IMPACT COME FROM?

- The economic impact of an industry is generated by expenditures on goods and services associated with ongoing equine activities.
- These expenditures represent the purchase of output of other industries and circulate throughout the entire local economy. In doing so these dollars:
 - Generate additional economic activity,
 - Support employment in the equine industry and all other sectors of the economy,
 - Generate household income, and
 - Provide tax revenue

METHODOLOGY


- DVU conducted a survey of equine industry participants in the 10-county region developed in conjunction with the Chester-Delaware County Farm Bureau.
- The survey was conducted on line using Survey Monkey as the vehicle and was active from February through April 2017.
 - Hard copy versions of the survey were distributed to potential respondents with no internet access.
 - The survey was publicized in Pennsylvania Equestrian, by word of mouth via the Farm Bureau, and fliers distributed to equine related businesses in the region.
- DVU received 613 completed surveys for an estimated 10.1% response rate. The largest number of responses were from Chester, Delaware, Bucks, and Montgomery Counties

Survey suggests that there are 50,225 equine in the 10-county region as of early 2017

Equine numbers have increased nearly 10% since 2012



Most popular breeds are Thoroughbreds, Warmbloods, and Quarter Horses




Equine industry spent \$546.2 million on goods and services in the 10-county region

Labor costs and feed accounted for the largest share of spending followed by purchases of equine.




The most frequently mentioned equine involvement is trail riding and pleasure

Boarding and training and breeding are the next most frequently mentioned activities.




The most frequently mentioned equine discipline is pleasure riding

Hunting and jumping and participation in Dressage events also are important activities




Survey respondents report devoting 8,602 acres to equine activities

Nearly twice as many acres are devoted to pasture than cropland and forage combined.



Survey respondents report devoting 8,992 acres to preservation and easements

Land devoted to agricultural preservation and conservation easements dominate land diversion



Economic Impact of Equine in Southeastern PA

- Equine make a substantial contribution to the regional economy.
 - Contributes \$657 million to Regional GDP
 - Provides \$501 million to regional household income
 - Supports nearly 6,556 jobs in all sectors of the regional economy
 - Generates more than \$57 million for State and local government coffers
